

Managing your property portfolio, selling land, booking hotel rooms or even renting a house is becoming easier, thanks to the rise of cutting-edge apps in the market.

The apps are increasingly taking over the work that used to be done by estate agents and land brokers,

App developers are riding on a strong Internet penetration in the country. One report this year said Kenya's Internet is one of the fastest in Africa and the Middle East. The report said that 21 million Kenyans enjoy Internet connectivity.

Here are some of the apps that have taken the centre stage in Kenya's real estate sector:

#### Mploti

Land buying and selling company Property Reality Company (PRC) recently an app called Mploti, which according to PRC chairman Brian Gacari will help cut out middle men in land transactions.

"Traditionally, land buying has been viewed as a complicated and rigid process. Mploti aims at changing this by allowing Kenyans to own land by paying as little as Sh500 per day as installment," says Gacari.

## What key players offer

The main player in app technology in housing today is Jumia House and Property24. An earlier player was Buyrent Kenya.
Jumia enjoys 50 per cent of the classifieds space market share.
OLX has also been workinghard to become a key player on this front.
Mploti allows land buyers to

pay in intallments, usually Sh500 per day.

Mploti app only requires one to text the word "Mploti" to 33300, and later reply with 1 to register, enter their full name and ID number.

#### Property24

Property24, a South African real estate company, has been operating in Kenya since 2013. Their app, Property24, brings Kenyan real estate together. When it was launched, it started as a free online housing market portal. Last year, they started charging agents to list their property on the portal.

their property on the portal.

"We have helped the Kenyan real estate agent by moving away from the traditional unregistered housing broker who used to take home hunters for viewing at a fee," says Githinji Muhoro, Property24 customer relations manager.

Muhoro's ays that about 20,000 properties have been listed on the app since

its launch. In the app, agents pay Sh3,500 for unlimited property entries per month or Sh2,300 for up to 10 properties per month.

They now have more than 400 agents who use the app on a daily basis to market their products.

#### Jumia House app

This app started as Lamudi. It allows a real estate professional to do everything with the click of a button. One can upload new properties, manage inventory, receive direct messages from clients, and even perform advanced competitor analysis. It is among the leading house selling and renting apps in Kenya.

"On average, we get 100 subscriptions and over 300,000 listings cumulatively. As at now, we are just short of 25,000 monthly listings for both rentals and sales," says Dan Karua, Jumia House MD.

Jumia House app has sold more than 5,000 homes since its inception with rentals that have gone in the portal standing at over 200,000 listings in the last four years. It registers more than five million hits in a year from house hunters.

#### Hilton Hhonuors app

Then there is the hospitality front. Earlier this year, Hilton Hotel launched Hhonuors app, a digital check-in portal, coming hot on the heels of the digital key portal, which was the first in the Hhonuors App series first rolled out in the United States market to the hotel chain's 400 outlets.

#### REAL ESTATE APPS GOOD FOR INDUSTRY, SAY PLAYERS

With a rising number of real estate stakeholders joining the online platform to undertake their business, many are asking: Could this be the beginning of the end of estate agents?

According to Martin Dais, the MD of FAPCL, a real estate consultancy and management company, property agents should learn to manage their listings more reliably, and fluidly at this time when real estate marketing is moving online.

"Using apps as property marketing tool helps agents to efficiently list and sell properties," says Dias. He says that at FAPCL, 30 to 40 per cent of the properties that they sell come from online portals.

Dan Karua of Jumia House says that apps will not eliminate the human element in real estate business any time soon. He says the apps just makes the work of the real estate sector players easier. "Online marketing is not silicing the cake but educating the market on the fact that it is revolutionalising the real estate market and creating a cake that is big enough for any real estate salesman," he says.

close to one year. It now opens over one million times every month, with nearly seven million rooms having been opened. It has also unlocked 350 doors since its launch in 2016.

"Guests will now be able to take advantage of Hilton's innovative technology platforms such as online checkin and the ability to choose individual rooms when booking via the Hilton Honours App," says the hotel.

In Kenya, the app is set to be rolled out in Hilton's recently-acquired 109room Amber Hotel on Nairobi's Ngong Road. The portal enables guest online booking and check-in without the help of a customer care agent.

# Affordability. NHC to build cheaper houses using EPS panels

The National Housing Corporation (NHC) has handed over another construction project built using the EPS technology to the National Police Service. The Expanded Polystyrene technology was first applied in Kenya in 2013 in building 44 police housing units in Ruai, Nairobi. The was handed over in September 2014. The latest project comprises a staff canteen, administration block, a car parking area, water reservoir and common cooking area. NHC has an EPS factory in Mavoko, Machakos County, where they manufacture panels using polystyrene. The panels are costeffective, safe and delivers a new construction faster than brick and mortar. The Ruai project took three months to complete. NHC MD Andrew Saisi said during the handing over of the police units that they working with national and county governments to build decent and affordable houses using such technologies. "We will continue to train artisans across the country on the use of EPS panels to enable deployment of the technology effectively," he said. [David Mwitari]

# Villagers whose land was taken for offices to be compensated

Residents whose land was acquired for the Sh220 million Lamu County headquarters in Mokowe will be compensated. Former Governor Issa Timamy rejected compensation calls, since the 22-acre land had already been set aside for the headquarters by the defunct municipal council. Mr Timamy said he would pay for crops and trees uprooted. The devolved unit has moved its headquarters from the island to Mokowe. Addressing a meeting in Mokowe yesterday, Governor Fahim Twaha said his administration would ensure the affected villagers were compensated adequately in order for them to get alternative land for settlement.

## Eight high-rise buildings to be demolished over safety concerns

More than eight high-rise buildings in Kisii Town are set to be demolished over safety concerns. National Buildings Inspectorate top officials led by Mr Moses Nyakiongora said the houses pose grave danger to occupants. Mr Nyakiongora further warned developers against flouting safety concerns when putting up storey buildings. "It is a matter of grave concern that unscrupulous and greedy developers had been flouting all rules of safety to set up houses which are becoming death traps," he told Nation. He was speaking yesterday after visiting the site of a four-storey building that collapsed in Kisii Town on Wednesday killing seven people and injuring 22 others. Mr Nyakiongora added that the government will also go for developers building on riparian lands.
