Officials in Kerio Valley to start compensation plan

Residents assured that grievances captured by task force will be considered

he government has dispatched a delegation of technical officials from various ministries to Kerio Valley to start the process of compensating land owners displaced by the collapsed fluorspar mining firm.

The multi-agency team drawn from the Mining ministry, office of the Attorney-General, National Land Commission and the Lands ministry, met with residents at Kimwarer where they also brought on board the county government of Elgeyo-Marakwet and the provincial administration.

Mr Silas Kinoti, a NLC commissioner, said the technical team's mission was to carry out the implementation of the compensation process and the re-opening of the collapsed company.

"This team you see here includes surveyors, physical planners, valuers and legal experts from the office of the Attorney-General and our mandate is to carry out the implementation of the compensation," said Mr Kinoti.

He said a list of 4,300 land owners were identified as genuine people displaced by the firm.

"The resource document we are working on was prepared by

a task Force which comprised of representatives of the affected residents and government officials," said Mr Kinoti, adding that the list was now supposed to be audited to ensure it is updated and valid.

The technicians will also be returning to the region in the next three weeks to continue with the implementation process, said Mr Kinoti, who is the official in charge of the team.

Mr Raymond Mutiso, the acting director at the Mining ministry,

said the government was aware of the community's grievances presented by their representatives whose proposals were captured in the task force's report.

"We had proposals that the community wanted land for compensation while others suggested money, but all the same the government will compensate every genuine person who was affected," said Mr Mutiso.

Elders and representatives recounted their long wait for pay, appreciating the efforts the government had commenced.

Politician Micah Kigen, who has fought for the rights of the displaced, told the meeting that the community's grievances including other injustices captured in the task force report should adequately be addressed.

How to avoid being conned when buying property

Many Kenyans planning to buy a home this year are perhaps already searching for bargain deals. For some, the search might end in pain and regret, thanks to fraudsters.

In my position as the chairman of a housing co-operative, I have heard of more than enough heart-breaking stories of investors who have lost their hard-earned money to con-men masquerading as sellers. It is believed that most of the victims are people without or little knowledge on property transactions. But I have also come across fairly knowledgeable buyers who have fallen prey to fraudsters.

Last year, for instance, saw many Kenyans lose their money in a homebuying scheme that turned out to be dubious. When the deal is too good, take to your heels.

At Nachu (National Cooperative Housing Union), we advise potential home buyers to conduct thorough due diligence on any property (land or a house) they plan to purchase, otherwise they might end up buying nonexistent property. Make sure the seller is the legal owner of the property or is the one legally authorised to sell it.

"As an investor, you must be sure you are dealing with an authentic firm," Francis Kamande, Nachu chairman

Fraudsters disguising themselves as "property agencies" hoodwink would-be buyers by establishing offices with all the trappings of an established property agency, including employing staff who help potential buyers to view the said "properties". After amassing enough income or running the risk of being caught, these "offices", "property", and the "sellers" suddenly vanish, leaving buyers bewildered.

And there is nothing stopping you from asking for the audited account reports for the previous year, the minutes for the company's Annual General Meeting, the loans they have taken and even the businesses they have transacted. Knowing someone or

being told of someone who has invested in a property by a particular housing cooperative or developer is not enough.

Conduct a search at the Ministry of Lands and engage a property lawyer to help you establish the legal status of the property – are there any encumbrances such as a bank loan, more than one title deed, is it public land, etc? [Francis Kamande]

Pick the perfect lawn grass

The confusion associated with picking the right lawn for your yard is not surprising. Kikuyu, arabica paspallum, Zimbabwe, cape royal, Bermuda, maadi river, buffalo, durban, bahia, carpet - I've even heard of Kidero - these are just but a few names that refer to the different lawn grasses. The difference between one and the other is sometimes not clear: they happen to be all green in the first place.

You don't need to be an expert in lawn grasses to pick the right one;

you only need to be familiar with the most common ones in your area. Here are some of them:

Kikuyu grass

Indigenous to the East African highlands where it thrives on roadsides and forest edges, Kikuyu grass is perhaps the best-known of our lawn grasses. It is a strong and aggressive perennial grass that will crowd off weeds and even invade nearby flowerbeds if not checked. It forms an attractive bright saladgreen cover that is thick, soft and somewhat springy.

The lawn will withstand light

trampling, hence no need to stop children from playing on it. Kikuyu grass, however, does not form the best lawn under shady condition and will turn brown soon after the onset of the dry season if supplementary watering is not provided.

Paspallum

Paspallum is a coarse-bladed dark green grass with pointed tips. Although it will grow well in both sun and shade, its leaves dry out and turn dark-brown soon after the onset of dry weather. It will, however, make an amazing recovery as soon as water becomes available again.

Paspallum spreads by surface stolons (runners) and is suitable for drives and for steep slopes. It is effective for controlling sheet erosion. It is strong and requires little weeding. It is, however, not suitable for sports grounds because heavy foot traffic soon exposes its stolons and the soil beneath.

Cynodon species

Cynodon is the name of a genera that contains a large number of grass species and varieties, some of which are popular lawn grasses. The most common ones include cape royal, bermuda grass, Maadi River and Arabica.

Cape royal produces a dense and fine lawn with wiry stems and narrow, relatively short leaves. It is fairly drought-resistant and is frequently used in semi-arid areas even though it will seldom remain green throughout in such environments.

Bermuda grass is no doubt the sports turf of choice. It produces an attractive, low maintenance lawn that makes excellent sports fields, parks, golf courses, and general utility spaces. It prefers full sun and supplementary watering during dry periods.
