

This Bill states that it seeks to "make provision for the training, registration and licensing of architects, quantity surveyors, landscape architects, interior designers, construction project managers and their related paraprofessionals, to achieve harmony in the regulation of professionals in the built environment; to provide for the establishment, powers and functions of the Built Environment Practitioners Board and for connected purposes."

Idle land to be taxed in new Ministry Bill

New law hopes to spur productive use for agriculture and commerce, says CS

the Ministry of Lands he Ministry of Lands has introduced a policy that will allow taxation of idle land. But the policy will be implemented only after both the Senate and the National Assembly adopt it

Assembly adopt it. Land CS Farida Karoney erday told Senators durin yesterday told Senators during the Inaugural Retreat for the Senate Committee on Land, Environment and Natural Re-sources in Mombasa that the two houses have a role to play in ensuring that the changes take affect.

"In our Rural Settlement Planning at the ministry, we have the land taxation policy that seeks to provide a package of incentives to encourage productive and sustainable use of land and disincentives for keeping idle land," said Ms Karpney.

She said among the aims is

to have all owners of idle land to be taxed to encourage sustainable use. She added: "This is pegged on the National Land Use Policy (NLUP). I am appealing to the Senate, through the committee, to support the fully implementation of the NLUP and the National Spatial Bleaning Relia (NLUP).

NLUP and the National Spatial Planning Policy (NSP)," she said.

The CS said the ministry needs adequate funding to ensure full implementation of its programmes. She said there are chunks of idle land that, were they well utilised for both agriculture and com-mercialisation, would make the country food secure and well developed.
"It is sad that we have all this

velopment. This is the land we are targeting. That land must be utilised for the growth of this nation," she said.

The CS called for a revisit of the land policy of 2009, saying it was adopted before the new Constitution. "The ministry is guided by the Constitution, the National Land Policy of 2009, and the enabling legislation in National Land Policy of 2009, and the enabling legislation in its work. But the current land policy was adopted in 2009, before the new Constitution, and needs to be revisited. She asked the Senate to encourage counties to allocate adequate funds to undertake their ohysical planning func-

their physical planning func-

"The Senate should fast-"The Senate should fast-track enactment of the Physical Planning Bill No. 34 of 2017 to provide the framework to guide the physical planning envisaged," she said. Senators took the minister to task over digitisation of all land transactions, which the ministry is currently imple-menting. "How safe is the digital online land transaction
