**KPDA PAYS THE NATIONAL BUILDINGS INSPECTORATE (NBI) A COURTESY CALL,
2ND AUGUST 2018**



Representatives from the KPDA Regulatory Bodies Working Group paid a courtesy visit to the **Secretary of the National Buildings Inspectorate, Qs. Moses Nyakiongora** at their offices in Works House.

During the meeting, NBI was able to share a brief on its objective to ‘ensure that a safe, healthy, quality sustainable built environment was achieved through observation of the laid down building regulations and standards thorough continous Quality testing, Audit and Inspections of unsafe buildings and structures.’

NBI was conceived as a result of Presidential Directive in 2015, following a spate of buildings collapsing in Nairobi. NBI is currently not anchored in any law the proposed **Built Environment Bill 2012** seeks to bring order in the booming construction industry by establishing minimum standards and practices will also establish the **Building Authority of Kenya**.

KPDA will be seeking to engage with NBI in order to establish a specific liaison to address member needs, carry out sensitization on buiolding safety and partner to train on building regulations and standards as well as the aspects of NBI’s Quality testing, Audit and Inspections of unsafe buildings and structures.

We will keep members posted as we continue to engage with the National Buildings Inspectorate.


