The STANLIB Fahari I-REIT is a closed-ended fund and its units are listed on the Nairobi Securities Exchange under the main markets segment under the Real Estate Investment Trust section code FAHR. Once the initial public offer was concluded in November 2015, units of the STANLIB Fahari I-REIT could only be traded through the NSE. Consequently, the market price of the Units is market driven and may not necessarily be equal to the Net Asset Value of the STANLIB Fahari I-REIT. However, the I-REIT Scheme may undertake secondary offers as and when the need arises.




MR. KENNETH KANIU, CEO - BRITAM ASSET MANAGERS
